Disposal of Examination Answer Books and Attendance Register of students :

The House discussed the matter in length and it was decided that since such provision is also existing in MSVE regulation of the VCI, the period and mode of disposal of above referred material can be fixed as decided by Board of Studies of the Faculty. Comptroller may circulate modalities to keep confidentidity and preventing the answer books becoming public by mistake.

The minimum cut off marks in RPVT examination:

The House discussed the matter in detail and it was decided that there is already scarcity of candidates appearing in RPVT, fixing of minimum cut off marks will further result in less number of students particularly in OBC/SC/ST categories and such decision shall not be fruitful. Hence, the agenda was not considered to be passed.

Honorarium to external members for committee of courses :

The House also considered the agenda and it was decided that the external members for committee of courses should be treated at par with external members of practical examinations and they should be provided honorarium on the same lines.

The Dean, PGS pointed out that as per revised rates, the external members are being provided Rs. 1500/- as honorarium. The house agreed to grant the same honorarium to external members for committee of courses.

It was pointed out by the Honb'le Vice-Chancellor that at present, university is paying Rs. 1000/- honorarium to each member of Board of

Directors as well as officers of different departments. The Controller of Exams. may decide the operational aspects with approval of Hon'ble Vice-Chancellor.
