	की पिछली बैठक के पश्चात् विश्वविद्यालय ने आशातीत प्रगति की है, इसके लिये पूरे
	विश्वविद्यालय व सदन की ओर से मैं राज्य सरकार, विशेषतौर से माननीय मुख्यमंत्री श्री
	अशोकजी गहलोत, माननीय कृषि एवं पशुपालन, डेयरी एवं मत्स्य मंत्री श्रीमान हरजीराम जी
	बुरड़क एवं प्रमुख शासन सचिव श्री मुकेश शर्मा का हार्दिक धन्यवाद देना चाहूंगा कि इन सभी
	के सहयोग का नतीजा है कि विश्वविद्यालय की स्थापना के पश्चात् अब तक कुल 421 नये

राशि भी वर्तमान वित्तीय वर्ष हेतु स्वीकृत की है।

विश्वविद्यालय नें रिक्त पदों को भरने की स्वीकृति भी राज्य सरकार से मांग रखी है। आशा है कि 128 रिक्त पदों के भरने के स्वीकृति भी राज्य सरकार से जल्दी ही मिल जायेगी, क्योंकि प्रकरण वित्त विभाग में परिक्षणाधीन है। इस प्रकार विश्वविद्यालय कुल लगभग 549 नये पदों पर नियुक्ति प्रक्रिया प्रारंभ कर चुका है। पदों की स्वीकृतियां मिलने के तुरन्त पश्चात् विश्वविद्यालय ने नियुक्ति प्रक्रिया जोर—शोर से शुरू कर दी है तथा मैं सदन को यह अवगत करवाना चाहूंगा कि विश्वविद्यालय इस बार आवेदन पत्र ऑनलाईन आमंत्रित करेगा तथा विज्ञापन का प्रचार—प्रसार समाचार पत्रों के माध्यम से करने के अतिरिक्त वेबसाईट व ई—मेल के माध्यम से पूरे देश के कृषि एवं पशु चिकित्सा विश्वविद्यालयों को सूचित करेगा।

इस विश्वविद्यालय को जयपुर में पी.जी.आई की स्थापना करनी है तथा प्रत्येक जिले में एक प्रशिक्षण व अनुसंधान केन्द्र भी स्थापित करना है अतः इस बाबत भूमि हेतु प्रस्ताव पशुपालन विभाग को भिजवाये जा चुके है, क्योंकि अनेक स्थानों पर इस विभाग के पास में अनुपयोगी भूमि विद्यमान है। विभाग द्वारा नागौर तथा भरतपुर जिलों में भूमि आवंटित कर दी गयी है तथा शेष स्थानों के लिये प्रकरण प्रक्रियाधीन है।

विश्वविद्यालय अब सुदृढ़ आर्थिक एवं मानव संसाधन आधार पर खड़ा है क्योंकि उपरोक्तानुसार पदों के अतिरिक्त विश्वविद्यालय को 12वीं पंचवर्षीय योजना में राज्य सरकार के माध्यम से लगभग 520.00 करोड़ का बजट भी प्राप्त होगा।

मैं सदन को यह भी अवगत करवाना चाहूंगा कि दिनांक 06.11.2012 को महामहिम माननीया कुलाधिपति महोदया ने विश्वविद्यालय का भ्रमण किया एवं एक छात्रावास का शिलान्यास भी किया। इससे पूर्व दिनांक 01.11.2012 को महामहिम द्वारा कुलपतियों की समन्वय समिति की बैठक में विश्वविद्यालयों को और अधिक सुदृढ़, आर्थिक एवं प्रशिक्षित मानव संसाधन उपलब्ध करवाने पर जोर दिया। इसके साथ ही उन्होनें यह भी प्रतिपादित किया कि सभी विश्वविद्यालयों को अपने आर्थिक स्त्रोत बढ़ाने होंगे एवं उपलब्ध संसाधनों का अधिक से अधिक उपयोग किया जाना चाहिये। माननीय कुलाधिपति महोदया अपने बीकानेर कार्यक्रम में विश्वविद्यालय के भ्रमण के दौरान विश्वविद्यालय की प्रगति एवं गतिविधियों से अत्यिधिक प्रभावित हुई, जो कि विश्वविद्यालय के लिये एक गौरव की बात है।

इस समयाविधि में विद्यार्थियों के व्यक्तित्व विकास एवं संवाद कौशलता में प्रवीणता हेतु कई प्रशिक्षण कार्यक्रम आयोजित किये गये। इसके सुखद परिणाम भी प्राप्त हुए। विश्वविद्यालय के सात विद्यार्थियों का लगभग रू. पाँच लाख के पैकेज पर गुजरात की एक अग्रणी डेयरी में चयन हुआ।

इस सदन के दो माननीय सदस्यों द्वारा 25 अक्टूबर, 2012 को 2 निजी सम्बद्ध महाविद्यालयों का निरीक्षण किया तथा उनमें चल रही परीक्षाओं में कुछ गंभीर अनियमितायें पाई। विश्वविद्यालय ने तुरंत निर्णय लेते हुये दोनों महाविद्यालयों की परीक्षायें निरस्त कर दी एवं दुबारा परीक्षायें विश्वविद्यालय के वीक्षकों के अधीन संपादित करवाइं। विश्वविद्यालय ने इस



तरह की घटनाओं की पुनरावृति रोकने के लिये Flying Squad तथा औचक निरीक्षण दल भेजने भी प्रारंभ कर दिये हैं, ताकि परीक्षायें सूचारू रूप से सम्पादित हो सकें। इसके साथ ही दोनों महाविद्यालयों पर 10.00 लाख रू. की शास्ति भी लगाई गई।

उपरोक्त सभी जानकारियों के साथ मैं सदन को यह आश्वस्त करना चाहूंगा कि विश्वविद्यालय का आधार बहुत सुदृढ़ है एवं अगले पाँच वर्षों में यह विश्वविद्यालय और अधिक प्रगति कर देश के अगृणी विश्वविद्यालयों के रूप में स्थापित हो सकेगा।

विश्वविद्यालय के इन प्रयासों के लिये माननीय सदन के साथ मैं राज्य सरकार का औपचारिक रूप से आभार प्रकट करता हूँ।

तत्परवात् डा. टी.के. गहलोत, निदेशक क्लीनिक ने पावर पाइंट प्रेजेंटेशन द्वारा पशु चिकित्सा सेवाओं को विस्तार से बताया, जिसकी सभी सदस्यों ने चिकित भाव से सराहना की। सदस्यों द्वारा विश्वविद्यालय द्वारा की गयी प्रगति की भूरी भूरी सराहना की गयी और इस के लिए सदस्यों ने माननीय कुलपति प्रोफेसर डा. ऐ. के. गहलोत एवं विश्वविद्यालय के staff के द्वारा किये गए प्रयासों की प्रशंसा की.


