CONDITION OF SUPPLY:-

1. Firm should be GST registered.

2. Rate should be quoted for ISI/genuine quality with suitable packing and expiry date (as per specifications provided)

Rate quoted should be F.O.R., at Klethora village of Gogunda block of Udaipur district, and should include installation charges etc. with inclusive of all taxes.

4. Carbon credit rates may also considered but in this case farmers contribution will be paid under the scheme

5. Supply will have to be made within one month from the date of the of work order.

(a) The quotation shall be valid for a period of two month from the acceptance.

(b) After a quotation has been accepted the rates shall remain valid for the period 11.10.2024 to 31th March 2025 and then the period can be extended by mutual agreement.

- 6. No counter proposals or modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the order is submitted in response to our quotation notice, it will be applicable to acceptance of terms and conditions given by us and no claims will be entertained.
