Terms and conditions:-

1. GST 18% extra
2. F.O.R:- Central Store, CVAS, Bikaner.
3. Validity:- Three Month
4. Warranty- Machine warranty Minimum 5 years & Air conditioner compressor warranty minimum 10 years
5. Judicial area: Bikaner.
6. Delivery:- All the rates are F.O.R. Destination (Free Delivery at central Store, CVAS, Bikaner and inclusive of packing & forwarding, freight, insurance, loading and unloading, Installation charges with outer iron stand, Cooper pipe-3mtr., Cable-5 mtr. each Air Conditioner). The above items should be supplied within 15 days from the date of supply order. Liquidated damages shall be recovered at the prescribed rates, if the firm fails to supply within the supply period, provided that the ordering authority on the request to the firm may be extend the supply period before its expiry after being satisfied with the reason given by the firm for inordinate delay in supplies. However, the extension of supply period may be with or without liquidated damages. In case of extension in the delivery period with liquidated damages recovery shall be made onthe basis of the following percentage of value of stores which the firm has fail to supply:-

- i) Delay upto one fourth period of the prescribed delivery:- 2.5%
 - ii) Delay exceeding one fourth but not exceeding half of the prescribed delivery period:- 5.0%
 - iii) Delay exceeding Half but not exceeding three fourth of the prescribed delivery period:- 7.5%
 - iv) Delay exceeding three fourth of the prescribed delivery period:- 10.0%
7. Other conditions of the tender shall remain the same as given under term and condition of the tender.
 8. Supply shall be accepted strictly according to the specification like make and model as mentioned in the bid/order.
 9. Final decision will remain with Dean's power to decrease/ increase of the quantity of approved items.
 10. The firm will execute an agreement (format enclosed) on Rs. 500/- Non-Judicial Stamp with the Dean, CVAS , Bikaner for and on behalf of Rajasthan University of Veterinary and Animal Sciences, Bikaner.
 11. The Bid Security Rs. 7200/- already deposited by you will be converted into bid performance security . Further you will have to deposit Rs. 3264/- through specified modes as mention in RTPP Rules 2013 as 5% as bid performance security of the entire supply of payment of bill amounting of Rs. 177354/- + GST 18% extra which will be kept pending till the warranty period. It is advised to complete the necessary formalities within 7 days from the date of this order.
 12. Besides the above terms and conditions, the general terms and conditions of RAJUVAS as well as RTPP Act, 2012 and RTPP Rule 2013 will also be applicable.
