LIMITED TENDER NOTICE

Please send your quotation for the supply of **Maplitho printing paper white original mill pkd. per rim (500 sheet packing) 78-80 GSM, size-23"x36"** from your ready stock in a sealed cover to the undersigned latest by 11.00 AM of 23-04-2026, below Rs 2.00 lakh.


Conditions of supply: -

1. Rates should be quoted for good quality paper showing the various details of specifications.
2. Rates quoted should be F.O.R. Store at DEE, RAJUVAS, Bikaner & inclusive of all taxes.
3. After the tender has been accepted, the rates shall remain valid for the period one year from the date of approved. The period can be extended by mutual agreement.
4. No counter proposals or modifications by the tenderer will be acceptable. The counter proposals stated in the tender will be ignored and once the tender is submitted in response to our tender notice, it will be made applicable to acceptance of terms & conditions given by us and no claims will be entertained. In other words, firm intending to give counter proposals should not submit tender at all.
5. Alternative specifications will not be acceptable.
6. Paper should be strictly accordingly to the specifications.
7. Paper will be procured on a monthly basis, as per the requirements of the office.
8. Cost of breakages & shortage during transaction would be deducted from the relative bills. No extra cost on such account will be admissible.
9. Tenders received after the prescribed time and date will be summarily rejected.
10. The cover containing the tender should be super scribed with following words for the supply of **Maplitho printing paper white original mill pkd. per rim (500 sheet packing) 78-80 GSM, size-23"x36"** and submitted to this office latest by 11.00 AM of 23-04-2026.
11. The tenders will be opened at 3.00 PM of 23-04-2026 in the office of the undersigned.
12. The purchasing officer is not bound to accept the lowest tender.
13. The decision of accepting authority shall be final as to quality of the stores.
14. Rejected articles will have to be removed by the tender at his own cost.
15. In case of local supplier, the rates should include all the taxes and no cartage or charges for transportation will be given by the University and the delivery of the goods shall be given at the premises of the University & its centres.
16. Remittance charge on payment made to the firm will be borne by the firm.
17. The insurance charge will have to be borned by the supplier if necessary.
18. No advance payment will be made.
19. Legal proceedings, if any, found necessary by any of the parties (University/Tenderer) shall have to be made in the courts situated at Bikaner and not elsewhere.
20. No other condition except those me mentioned above will be entertained.
